How to Say It

Box 6601, Newport News, VA 23606, the sum of \$______(or ____% of the rest, residue, and remainder of my estate) for its general purposes (or other purposes).

Retirement Plans

Subject to multiple types of taxes, IRAs, 401(k)s, and other qualified retirement plans are the best – and easiest – assets to leave to charity. You can designate all or a portion of the funds remaining in your plan as a gift to the ACB.

How to Include the ACB in Your Retirement Plan

- Request or download a beneficiary form from your retirement plan manager.
- Designate the ACB as a partial, contingent, or sole beneficiary of your account.
- If you are married, your State may also require a spousal waiver form, which can be obtained from your account manager.

Bank and Brokerage Accounts
